- (a) To receive the funds from the Ministry of Rural Development, Government of India.
- (b) To maintain account of the PMGSY and funds in selected Bank Branch.
- (c) To vet the proposals before they are put up before the State Level Standing Committee and are sent to the National Rural Roads Development Agency (NRRDA) for clearance by the Ministry of Rural Development, Government of India.
- (d) To consider any other matter as per the revised guidelines of the PMGSY scheme and those issued by the Ministry of Rural Development, Government of India in the best interest of implementation of works.
