No.DC/L/VII/5/2007/6/2391.—In pursuance of paragraph 11 of the Sixth Schedule to the Constitution of India, the following Amendment Bill of the Khasi Hills Autonomous District Council is hereby published for general information :-

THE KHASI HILLS AUTONOMOUS DISTRICT (ELECTORS FROM THE TWENTY THREE CLANS OF RAID SAN SHNONG OF MYLLIEM SYIEMSHIP) (FIRST AMENDMENT) ACT, 2007.

(Passed by the Khasi Hills Autonomous District Council on the 26th June, 2007)

AN

ACT

to amend the United Khasi-Jaintia Hills Autonomous District (Electors from the twenty three Clans of Raid San Shnong of Myllem Syiemship) Act, 1957 hereinafter referred to as the 'Principal Act' in the manner herein appearing.

It is hereby enacted by the Khasi Hills Autonomous District Council in the Fifty Eighth year of the Republic of India as follows:-

- Short title, Extent and Commencement :-
 - This Act may be called the Khasi Hills Autonomous District (Electors from the twenty three Clans of Raid San Shnong of Myllem Syiemship) (First Amendment) Act, 2007.
 - It shall have the like extent as the Principal Act.
 - It shall come into force at once.
- In the Principal Act for the words "the United Khasi-Jaintia Hills Autonomous District" and the words "the United Khasi-Jaintia Hills District" wherever they occur, the same shall be substituted by the words "The Khasi Hills Autonomous District".

3. Amendment of Section 2 of the Principal Act :-

In the existing sub-section (a) of Section 2 of the Principal Act, between the words "Assam" and "Autonomous", the words "and Meghalaya" shall be inserted.

4. Amendment of Section 3 of the Principal Act :-

In the existing Proviso to Section 3 of the Principal Act;

(i) the words "shall not" appearing in the second line of the proviso between the words "Durbar" and "sit" shall be substituted by the words "may also", and

(ii) the word "but" appearing in the third line of the proviso between the words "Syiem" and "that" shall be substituted by the word "and".

STATEMENT OF OBJECTS AND REASONS

It has become necessary to amend the Principal Act in order to remove any discrepancy among the electors of Myllem Syiemship for improving its administration.

Hence this Amendment Act.
