No.CA.24/2009/31.—The Governor of Meghalaya is pleased to order that Water Resources Department shall have the following functions namely :-

1. All activities relating to survey and investigation, planning, construction, establishment, implementation, management and monitoring of Minor and Medium irrigation projects and schemes.
2. Technical guidance and advisory services to Departments and agencies of the Government of Meghalaya in respect of provision of minor and field level irrigation services including lift and flow irrigation and drip irrigation.
3. Command Area Development and support to land based Departments of the Government of Meghalaya for production and cultivation planning and implementation activities in command areas developed by the Department of Water Resources.
4. Development and promotion of Participatory Irrigation Management and support to the activities of Water User Associations in the rural sector.
5. Capacity building of engineering, technical and professional staff and personnel of the Water Resources Department and the Department of Agriculture and related agencies in the areas of water conservation, management and utilization for agriculture.
6. Coordination of hydrological and ground water resource assessments for the State of Meghalaya.
7. Evolution of medium and short term perspective on water conservation, management and utilization for the State of Meghalaya.
8. Assessment of ground and surface water potential for irrigation and other uses.
9. Ground Water management and regulation.
10. To transfer flood control activities from P.W.D. to the Department of Water Resources, with the exception of the Rongai Valley Medium Irrigation Scheme, which will continue to be dealt with by Public Works Department.

No.F(PR)-71/09/15 dated 24.9.2009 and to clarify that where the age of the pensioner/family pensioner has not been recorded in the Pension Payment Order, the Pension Disbursing Authority, i.e., the Treasury Officer/Selected Public Sector Banks are authorized to obtain the information/materials from the Pensioner/Family Pensioner and forward the same to the Pension Sanctioning Authority for authentication thereof. Rule 59 (a) of the Meghalaya Civil Services (Pension) Rules, 1983 states that the appointing authority is the competent Pension Sanctioning Authority.

Cases of the nature may be forwarded by the Pension Disbursing Authority concerned direct to the Pension Sanctioning Authority with details of the P.P.O No. etc., who will, after verification/authentication, intimate the Accountant General (A&E), Meghalaya for issue of Pension Payment Order for additional quantum of pension/family pension in terms of Para 4.5.2. of the above mentioned O.M.
