DECLARATION

No.RDA.75/2011/53.

Whereas it appears to the Government of Meghalaya that land is required to be taken by the Government at the public expense for a public purpose viz. the construction of Inter State Bus Terminus under BSUP at Mawiong, Shillong in the District of East Khasi Hills, it is hereby declared that for the above purpose, land measuring more or less 53041.74 Sq.m., as per the boundaries details below:

SCHEDULE OF BOUNDARIES.

North :-	Proposed approached Road and land of Smti. Bajoplin Thawmuid & Land of Thangkhiew.
East :-	Proposed approached Road and land of Thangkhiew.
South :-	Land of Smti. Bajoplin Thawmuid.
West :-	Land of PHE Department and land of Bajoplin Thawmuid.

This Declaration is made under the provisions of Section 6 of Act 1 of 1894 which was amended by Act 68 of 1984 to whom it may concern.

A map of the plot of land may be inspected in the office of the Deputy Commissioner, East Khasi Hills District, Shillong, on working days.

Nothing in this Declaration will be considered to apply to land which is resumable for the said purpose under the terms of the Lease and which Government elects to resume instead of acquiring under the Act.

OFFICE MEMORANDUM

Subject :- Fixation of pay – Relaxation thereof.

No.F(PR)-89/2009/30.

The undersigned is directed to say that consequent upon the decision taken by Government to improve/modify the pay scale(s) of certain post(s) on the recommendation of Anomaly Committee, re-fixation of the pay of the holder(s) of such post(s) in the improved/modified scales of pay, as per provisions laid down in the M.S. (ROP) Rules, 2009, has resulted in substantial drop in the pay of such employee(s) as compared to his/her/their pay fixed earlier in the corresponding revised scale(s) applicable to the post (s). In order to alleviate the difficulties of the employees and to protect their legitimate dues, the Governor of Meghalaya, in exercise of the powers conferred by Rule 15 of the M.S.(ROP) Rules, 2009, is pleased to decide that in all cases where re-fixation in the improved/modified scales of pay has resulted in drop in pay, such employees shall be allowed to elect for either of the following options:-

- (i) opt for the improved/modified scale of pay with effect from 1.1.2007;
- or,
- (ii) opt to retain the corresponding revised scale of pay notified under Notification No. F(PR)-69/2007/37 dated 3.3.2010 until they vacate the post (s) or cease to draw pay in the scales of pay.

3. The option, once exercised, shall be final and shall not be withdrawn or modified at any subsequent date. An option, in the prescribed form (Appendix I), shall be submitted to the respective heads of Office/Accountant General within a period of 60 days from the date of issue of this Office Memorandum. If the intimation regarding the option is not received within the specified time limit, the Government employee (s) shall be deemed to have opted for the re-fixation of their pay in the improved scale(s) with effect from 1.1.2007.
