No. JHADC/TAX/8/2012/5.—In supersession of this Office Notification No. JHADC/TAX/19/92/3 dated 28th December, 1992 the Executive Committee, Jaintia Hills Autonomous District Council, Jowai is pleased to adopt and enforce the rates of Taxes on Professions, Trades, Callings and Employments as revised by the Meghalaya Professions, Trades, Callings and Employments Taxation (Amendment) Act, 2012 as detailed below:-

SCHEDULE OF RATES OF TAXES:

Where the cross total annual income	Amount of Tax
(a) Does not exceed Rs. 50,000/-	Nil
(b) Exceeds Rs. 50,000/- but below Rs. 75,000/-	200
(c) Exceeds Rs. 75,000/- but below Rs. 1,00,000/-	300
(d) Exceeds Rs. 1,00,000/- but below Rs. 1,50,000/-	500
(e) Exceeds Rs. 1,50,000/- but below Rs. 2,00,000/-	750
(f) Exceeds Rs. 2,00,000/- but below Rs. 2,50,000/-	1000
(g) Exceeds Rs. 2,50,000/- but below Rs. 3,00,000/-	1250
(h) Exceeds Rs. 3,00,000/- but below Rs. 3,50,000/-	1500
(i) Exceeds Rs. 3,50,000/- but below Rs. 4,00,000/-	1800
(j) Exceeds Rs. 4,00,000/- but below Rs. 4,50,000/-	2100
(k) Exceeds Rs. 4,50,000/- but below Rs. 5,00,000/-	2400
(l) Exceeds Rs. 5,00,000/-	2500

The Head of Account to which the tax shall be credited is 8443 - Civil Deposit: 120 Deposit of Autonomous District Council and Regional Fund Jowai District Council.

The above rates of taxes shall take effect from the 1st April, 2012.

Formal amendments to the United Khasi and Jaintia Hills (Taxation on Profession, Trades, Callings and Employments) Regulation 1960 as adopted by this District Council shall be made in due course.
