#### NOTIFICATION

**No.HPL.113/2016/324.-** Whereas for public convenience and better administration the Governor of Meghalaya considers it necessary to create a new Police Station at **Siju** in the South Garo Hills District to be known as the **Siju Police Station**.

And, whereas, it is necessary to describe the boundaries and jurisdiction of the new Police Station as indicated here-under;

Now, therefore, the Governor of Meghalaya is pleased to order creation of the aforesaid Police Station at **Siju** and to describe the boundaries and jurisdiction of the new Police Station as indicated hereunder with effect from the date of publication of this Notification in the Official Gazette of Meghalaya. On creation of the **Siju Police Station** the areas coming under its jurisdiction shall cease to be under the **Baghmara Police Station**.

#### **DESCRIPTION OF THE BOUNDARIES OF THE SIJU POLICE STATION**

**NORTH :** Rongdong stream and Nangalbibra Police Station.

**EAST :** Arateka, Rongsu Agalgre, Rongsu Mongbetgittim, Chitmong Gonggrot, Rongara Police Station

**SOUTH :** Karukol Baikal, Rewak Kemdang, Rongaigittim, Nengkong Madang, Nengkong Bazar, Ringrangre upto upper Dosagre.

**WEST :** Tolegre, Aruwak Nokatgre, Gongjagre and Dabalgre.
