The Bye-laws amended and registered this day the 8<sup>th</sup> March, Two Thousand Eighteen are as follows:-

Partial Amendment of Bye-Laws Nos.

<b>Bye-Law No.8 Admission Fee</b>	Every person desirous of becoming an 'A' class member shall have to pay an admission of ₹ 200/- (Rupees two hundred) only irrespective of number of shares applied for. The payment of the admission fee and the share value, his name, designation address and other particulars appearing in his application for membership shall be entered in the Register of Membership and he shall then be deemed to have acquired all the rights, obligations and responsibilities of a member.
<b>Bye-Law No. 9 (c)</b>	<b>Duplicate Share Certificate:</b> If a share certificate is defaced, lost, destroyed, stolen or otherwise mutilated while in the custody of the holder, it may be renewed on payment of ₹ 100/- (Rupees one hundred) for each such certificate, over the signature of the Secretary, record being kept on the counterfoil of the original certificate as well as register of shares and the word 'Duplicate' being written in red ink on the face of such certificate.
<b>Bye-Law No. 11</b>	<b>Ceasation of membership:-</b> Membership shall be cease by: (1) Resignation from Society, (2) Resignation from service, (3) Removal or dismissal from service, (4) Expulsion as defined in Bye-Law 13, (5) Bankruptcy (6) Lunacy and (7) Death.  Note: If a member cease his membership by resignation from the Society he shall not be eligible for fresh membership of the Society at least for a period of one year from the date of such ceasation and also cannot take active participation in election of Board of Director for a period of 3 years from the date of fresh membership.

<b>Bye-Law No.9(8) (a)</b>	Current Account or Saving Bank Account  (a) The working fund of the Society shall be kept in the current account or Saving Bank Account of the Local Branch of the Meghalaya Co-operative Apex Bank Ltd. or State Bank of India provided that if there is no such branch in India provided that if there is no such branch in the Civil Administrative area in which the Society is located, the Managing Committee may decide to keep the funds of the Society in the Post Office saving Bank or any Schedule Bank as approved by the Registrar of Co-operative Societies. The Chairman and the Secretary of the Society shall operate the current account accordingly to such rules as may be prescribed.
<b>Bye-Law No. 10(1) (iv)</b>	Up to 12.5% as dividend on paid up share.
<b>Bye-Law No. 10(1)(v)</b>	Up to 20% as remuneration to the members of the Managing Committee according to work do by each member.
