**OFFICE MEMORANDUM**

**Subject:-** *Fixation of Pay – Relaxation thereof.*

**No.F(PR)-70/2017/155.** - The undersigned is directed to say that consequent upon the decision taken by Government to improve/modify the pay level of certain posts, re-fixation of the pay of the holders of such posts in the improved/modified pay levels, as per provision laid down in the M.S. (RoP) Rules, 2018, has resulted in substantial drop in the pay of such employees, as compared to the pay fixed earlier in the corresponding revised pay levels applicable to the post. In order to alleviate the difficulties of the employees and to protect their legitimate dues, the Governor of Meghalaya, in exercise of the powers conferred by Rule 14 of the M.S. (RoP) Rules, 2018, is pleased to decide that in all cases where such re-fixation in the improved/modified pay levels has resulted in drop in pay, such employees shall be allowed to elect for either of the following options:-

- i. Opt for the improved/modified pay level with effect from 1<sup>st</sup> January, 2017.

or,

- ii. Opt to retain the corresponding revised pay level as notified under Notification No.F(PR)-77/2017/117, dated 1<sup>st</sup> March, 2018 until they vacate the post or cease to draw pay in the pay level.

The option once exercised, shall be final and shall not be withdrawn or modified at any subsequent date. An option, in the prescribed form (Appendix-I), shall be submitted to the respective Heads of Offices/Accountant General within a period of 60 days from the date of issue of this Office Memorandum. If the intimation regarding the option is not received within the specified time limit, the government employee shall be deemed to have opted for the re-fixation of their pay in the improved pay level with effect from 1<sup>st</sup> January, 2017.
