No. POL.161/2012/Pt/154. - The following Resolution dated 16th March, 2020 passed by the Meghalaya Legislative Assembly is hereby published for general information.

MEGHALAYA LEGISLATIVE ASSEMBLY

RESOLUTION

Whereas, the Citizenship (Amendment) Act, 2019 has come into force with publication in the Gazette of India on 12th December, 2019 and the Act provides that it "shall not apply to tribal area of Assam, Meghalaya, Mizoram or Tripura as included in the Sixth Schedule to the Constitution";

Whereas, the Citizenship (Amendment) Act, 2019 applies to areas in the State not covered under the Sixth Schedule to the Constitution i.e., the municipality of Shillong as defined in para 20 of the Sixth Schedule to the Constitution, and hence additional measures are required to protect and safeguard the interests of the tribal population of the State.

Now, therefore this House thanks the Government of India for exempting the Sixth Schedule Areas of the State from the purview of the Citizenship (Amendment) Act, 2019 and resolves that the Government of India

be urged to exempt the entire State including the areas not covered under the Sixth Schedule from the purview of the said Act.

Certified that the above Resolution was unanimously approved by the Meghalaya Legislative Assembly on 16th March, 2020.
