No. JHADC/LEG/11/2020/28.- In pursuance of Paragraph 11 of the Sixth Schedule to the Constitution of India, the following Act of Jaintia Hills Autonomous District Council is hereby published for general information:-

The Jaintia Hills Autonomous District (Establishment of Elaka and Village and Election, Appointment, Powers, Functions and Jurisdiction of Dolloi/Sirdar and Waheh Shnong) (First Amendment) Act, 2020.

The Jaintia Hills Autonomous District (Establishment of Elaka and Village and Election, Appointment, Powers, Functions and Jurisdiction of Dolloi/Sirdar and Waheh Shnong) (First Amendment) Act, 2020.

AN

ACT

to further amend the Jaintia Hills Autonomous District (Establishment of Elaka and Village and Election, Appointment, Powers, Functions and Jurisdiction of Dolloi/Sirdar and Waheh Shnong) Act, 2015.

Preamble:-

Whereas it is expedient to further amend the Jaintia Hills Autonomous District (Establishment of Elaka and Village and Election, Appointment, Powers, Functions and Jurisdiction of Dolloi/Sirdar and Waheh Shnong) Act, 2015, herein after referred to as the "Principal Act" in the manner, herein after appearing.

It is hereby enacted in the **Seventy-first Year of the Republic of India** as follows:-

1. Short title, extent and commencement:-

- (1) This Act may be called the Jaintia Hills Autonomous District (Establishment of Elaka and Village and Election, Appointment, Powers, Functions and Jurisdiction of Dolloi/Sirdar and Waheh Shnong) (First Amendment), Act, 2020.
- (2) It shall extend to the whole of Jaintia Hills Autonomous District.
- (3) It shall come into force at once.

2. Amendment of Appendix- II of the Principal Act

In Serial No. 16 of Appendix-II of the Principal Act, in the column for Eligible clans, after the figure and words "5. Jaid kur Shylla-Rabon", the figure and words "6. Jaid kur Papang" and "7. Jaid kur Mynso" shall be added.

STATEMENT OF OBJECTS AND REASONS

The claim of Papang clan and Mynso clan of Shangpung Elaka as the eligible clan to contest the election of the Dolloi has a place to stand by being the candidature in the Shangpung Dolloiship Election in 1964 during the administration of the erstwhile United Khasi and Jaintia Hills Autonomous District Council. On investigation and proper examination it is found suitable to be incorporated in the Act.

Hence this Amendment Act.


