Preliminary Notification

(Under Section 11 (1) read along with Section 40 of the Act-30/2013)

No.RDA.35/2021/320. - Whereas it appears to the Government of Meghalaya that a total of **588907.77 Sq.mt.** more or less of land is required at **Sumer Latara, Sumer No. 4, Umramblei, Mairung-Pdeng, Mairung-Heh, Nongkyndong lapwar, Mawlyndep, Umsiej and Umraleng** villages of Ri-Bhoi District, for public purpose, namely, for **Construction of 2 Lane with paved shoulder of Shillong Western By-Pass**

Therefore, it is notified that for the above said project in the village Sumer Latara, Sumer No. 4, Umramblei, Mairung-Pdeng, Mairung-Heh, Nongkyndong lapwar, Mawlyndep, Umsiej and Umraleng of Ri-Bhoi District, the land measuring **588907.77 Sq.mt.** more or less whose details description is given in schedule to this notification, is under acquisition.

The Additional Deputy Commissioner (Revenue), Ri-Bhoi District, Nongpoh is appointed as Administrator for the purpose of Rehabilitation and Resettlement of the affected families.

This notification is made under the provisions of Section 11(1) *read* along with Section-40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No.30/2013), to all whom it may concern.

A plan of the land may be inspected in the office of the Deputy Commissioner, Ri-Bhoi District on any working day. The appropriate government is pleased to authorize the Deputy Commissioner and his staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil and do all others acts required for the proper execution of their work as provided and specified in Section 12 of the Act.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land *i.e.* sale/purchase, specified in the preliminary notification or create any encumbrance on such land from the date of publication of such notification without prior approval of the District Collector.

The objection to the acquisition, if any, may be filed by the person interested within 60 (sixty) days from the date of the publication as provided under Section 15 of the said act before the District Collector, Ri-Bhoi District, Nongpoh.
