No.RDA.59/2017/141. - Whereas it appears to the Government of India, Ministry of Finance that a total area **347.035 Square Meters** of land is required in **Borsora Village, Ranikor Civil Sub-Division, South West Khasi Hills District** for construction of Custom's office (Borsora Land Custom Station).

The Additional Deputy Commissioner (Revenue), South West Khasi Hills District is appointed as Administrator for the purpose of rehabilitation and resettlement of the affected families.

Therefore, it is notified that for the above said project located at Borsora village of the South West Khasi Hills District, a piece of land measuring more or less **347.035 Square Meters** whose details description is given in schedule to this Notification is under acquisition.
