Bye-Law No. 45 Cash in Hand	The Secretary or the paid employee authorized by the Managing Committee in that behalf may retain in his personal custody, at the close of any day a sum not exceeding ₹ 50,000/- (Rupees fifty thousand) only for a day-to-day expenses. If due to unavoidable circumstances, the cash in hand has exceeded the above limit, the excess cash shall be credited into the bank within the next 2 (two) days by the Secretary or any other person authorized by the Managing Committee to keep cash in hand. All the normal payments made by the Society shall be by cash or cheque only.
