III/393. - In exercise of the powers conferred by sub-sections (3) and (4) of section 9, sub-section (1) of section 11, sub-section (5) of section 15 and section 148 of the Meghalaya Goods and Services Tax Act, 2017 (Act 10 of 2017), the Government of Meghalaya, on being satisfied that it is necessary in the public interest so to do, on the recommendations of the Council, hereby makes the following amendment further to amend the notification of the Government, Excise, Registration, Taxation and Stamps Department, No.ERTS (T) 65/2017/12, dated the 29th June, 2017, published in the Gazette of Meghalaya, Extraordinary, Part-IIA, *vide* No. 99, dated the 5th July, 2017, namely:—

In the said notification, in paragraph 3, in the Explanation, after clause (iv), the following clause shall be inserted, namely:-

"(iva) For removal of doubts, it is clarified that any authority, board or body set up by the Central Government or State Government including National Testing Agency for conduct of entrance examination for admission to educational institutions shall be treated as educational institution for the limited purpose of providing services by way of conduct of entrance examination for admission to educational institutions."

In the said notification, -

- (i) in Schedule I - 2.5%, against Sl. No. 91 A, in column (3), for the entry, the following entry shall be substituted, namely: -

Preliminary Notification

(Under Section 11 (1) READ ALONG WITH SECTION 40 of the Act-30/2013)

No.RDA.17/2022/16. - Whereas it appears to the Government of Meghalaya that a total of 360845 Square Meters of land is required in Muktapur, Lakroh, Hawaii, S.P. Tila, Sankhat, Jaliakhola and Pasadwar, West Jaintia Hills District, for public purpose, namely, for construction of Indo Bangladesh Border Fencing (IBBF) BP.No.1273/MP to BP.No.1302/4s as per boundaries described in the schedule attached.

Therefore, it is notified that for the above said project Muktapur, Lakroh, Hawaii, S.P. Tila, Sankhat, Jaliakhola and Pasadwar, West Jaintia Hills District, a piece of land measuring more or less 360845 Square Meters whose detailed description is given in the Schedule to this Notification, is under acquisition.

This Notification is made under the provision of section 11 (1) *read* with Section 40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30/2013), to all it may concern.

The appropriate Government is pleased to authorize the Deputy Commissioner and his staff to enter upon and survey land, take levels of any dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provide as specified in section 12 of the said Act.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase, specified in the preliminary notification or create any encumbrances on such land from the date of publication of such notification without prior approval of the District Collector.

This notification is made under the provision of section 11(1) *read* along with Section 40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.
