No.PW/ADMN/92/2015/Pt/255. - In exercise of the powers conferred by the proviso to Article 106 of the Memorandum and Articles of Association of the Meghalaya Government Construction Corporation Limited (MGCCL), the Governor of Meghalaya is pleased to amend the following Article regulating appointment of Chairman, Managing Director and other Directors as follows:-

1. **Short title and commencement:** (1) This amendment shall be called the Memorandum and Articles of Association of the Meghalaya Government Construction Corporation Limited (First Amendment), 2022.

(2) They shall come into effect from the date of issue of this Notification in the Official Gazette.

2. **Amendment of Article 62:** The existing Article 62 of the Memorandum and Articles of Association of the Meghalaya Government Construction Corporation Limited (MGCCL) be deleted and substituted as follows:-

"62. - Appointment of Chairman, Vice Chairman, Managing Director and other Directors".

1. The Governor shall have the right to appoint Directors.
2. The Governor shall appoint one of the Directors as the Chairman, 2 (two) of the Directors as Vice Chairmen and another as the Managing Director either for fixed term or without any limitation as to the period for which he is to hold office.
3. The Chairman, Vice Chairmen, The Managing Director and other Directors shall be paid such salary and/or allowances as the Governor may from time to time determine, subject to the provisions of Section 314 of the Act.
4. The Chairman, Vice Chairmen, the Managing Director and other Directors appointed by the Governor shall hold office until removed by him and in the event of such removal or in the event of any vacancy in their offices either by resignation, death or otherwise the Governor shall be entitled to appoint others as Chairman, Vice Chairmen, Managing Directors and Directors in their places.
5. At every Annual General Meeting of the Company all the Directors (including the Chairman, Vice-Chairmen) except the Managing Director shall retire from Office. The Managing Director shall retire on his ceasing to hold the office of the Managing Director. A retiring Director shall be eligible for reappointment.
