(Demands for grants for the year 2023-2024)

A
BILL

to authorize payment and appropriation of certain sums from and out of the Consolidated Fund of Meghalaya for the services of Financial Year ending on the thirty first day of March, 2024.

Be it enacted by the Legislature of the State of Meghalaya in the Seventy Fourth Year of the Republic of India as follows:-

Short title and Commencement	1. (1) This Act may be called the Meghalaya Appropriation (No. II) (Demand for the grants for the year 2023-2024) Act, 2023. (2) It shall come into force on the first day of April, 2023.
Withdrawal of ₹ 22022,22,00,000/- from and out of the Consolidated Fund of Meghalaya for the Financial Year 2023-24	2. From and out of the Consolidated Fund of Meghalaya, there may be paid and applied sums not exceeding those specified in column (3) of the Schedule amounting in the aggregate inclusive of sums specified in column (3) to the sum of ₹ 22022,22,00,000/- (Rupees twenty two thousand twenty two crores and twenty two lakhs) only towards defraying the several charges which will come in course of payment during the financial year ending on the thirty first day of March 2024 in respect of the services specified in column (2) of the Schedule.
Appropriation	3. The sums authorized to be withdrawn from and out of the Consolidated Fund of Meghalaya by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the financial year 2023 – 2024.
