3. Woolen serge Trousers Khaki with three loops.
4. Angola Khaki shirt full sleeve with shoulder strap and bokrom.
5. Drill cloth Khaki trousers long with three loops.
6. Cellular cloth shirt Khaki two chest pocket with shoulder strap.
7. Khaki woolen great coat with half lining.
8. Stitching of Fire Dungaree for F&ES.

The stitching pattern of the Fire Dungaree will be as follows:-

1. 2 (two) white reflective stripes of 1" size on the both arms.
