5. Tender to be properly sealed and the words "Diet ETC. Medical INSTITUTION" to be superscripted in bold letters on the body of the cover bearing the name and address of the Tenderer.
6. Tender or Tenderer whose wife or husband as the case may be working either in the office of "Civil Hospital"/District Medical & Health Officer will not be considered.
7. No withdrawal of any terms and condition of the tender will be allowed after the tender have been opened. Further, the tender submitted will not be allowed to withdraw the finalization of the tender and such if any tenderer withdraws, his/her earnest money will be forfeited to the State Government and this will be taken into account and such tenderer or contractor may be debarred from tendering any tender in future.
8. Rate quoted for all items should be clearly written in both figures and words and rate should be inclusive of all taxes.

Eggs in particular must be fresh and if after boiling these are found decomposed or unsuitable for consumption the Indenting Officer shall purchase from any easily available sources for some time if arrangement for immediate replacement is not possible, the selected tenderer shall be under obligation to bear the extra cost involved in such purchases.
14. Ration commodities, indenting officer or any person authorized by the indenting officer of the respective institution shall check the articles at the time of delivery and any defects found shall have to be rectified by the selected tenderer. All such rejected stuff shall have to be removed by the contractor forthwith at his own expenses. In case of any disagreement the decision of the Indenting Officer shall be final and binding on the selected tenderer.
15. The quantity shown against each is approximately as a very rough guide and the actual quantity to be ordered will depend on requirement to be determined by the Indenting Officer. No claim for compensation will be entertained in case of fluctuation to the quantity demanded.
16.
