**No.Health.156/2018/Pt/44.** - Pending framing and finalization of the Meghalaya Family Welfare Education Service Rules, the Governor of Meghalaya is pleased to order that the following procedure should be followed in the matter of recruitment/promotion to the following post in the Office of the Directorate of Health Services (MCH & FW), Meghalaya under the jurisdiction of Health & Family Welfare Department with immediate effect:-

1. **District Extension & Media Officer (DE & MO):** Appointment to the post of District Extension & Media Officer [DEMO] shall be made by promotion in consultation with the MPSC from amongst the senior most Senior Health Inspector [SHI] / Deputy District Extension & Media Officer [Dy. DEMO] / Block Extension Educator [BEE] working in the Directorate of Health Services (MCH & FW), Meghalaya on the basis of Seniority-cum-Merit having rendered at least 8 (eight) years of continuous service in that post as shown in Schedule-II.
2. **The Posts of Senior Health Inspector (SHI) / Deputy District Extension & Media Officer [Dy. DEMO] and BEEs** have the same Pay Level-11, hence any senior most BEE who have rendered at least 5 (five) years of field experience & continuous service in that post can be placed in the post of SHI / Dy. DEMO.
3. **Block Extension Educator (BEE):** Appointment to the post of Block Extension Educator (BEE) shall be made by direct recruitment on the recommendation of the Meghalaya Public Service Commission as shown in Schedule-II.
4. **Other Conditions:** The existing policy of the Government on reservation of the posts and other conditions of services prescribed by Government from time to time as required to be strictly followed.
5. **Departmental Promotion Committee:** There shall be a Departmental Promotion Committee for the purpose of appointment by promotion to the post of District Extension & Media Officers in the Office of the Directorate of Health Services (MCH & FW), Meghalaya consisting of the following members:-
  - i. Principal Secretary/Commissioner & Secretary/Secretary to the Govt. of Meghalaya, Health & Family Welfare Department. - Chairman
  - ii. Principal Secretary/Commissioner & Secretary/Secretary to the Govt. of Meghalaya, Personnel & AR Department. - Member
  - iii. Principal Secretary/Commissioner & Secretary/ Secretary to the Govt. of Meghalaya, Finance Department. - Member
  - iv. Director of Health Services (MCH & FW), Meghalaya, Shillong. - Member SecretaryThe Committee may invite any other person to attend its meeting as and when considered necessary.
6. The number of post in each category and scale of pay of each post is as shown in the Schedule I.
7. These orders shall remain in force till the promulgation of the Service Rules of the Family Welfare Education in the Directorate of Health Services (MCH & FW), Meghalaya.

- ii. Every employee working in the establishment shall be given one day holiday in a week without making any deductions from his/her wages on account thereof and list of the time table of such holidays for a month shall be placed on the notice board in advance.
- iii. Every employee shall be given a rest period of one hour after 5 hours of continuous work.
- iv. No employee shall be required to work for more than 9 hours in a day or 48 hours in a week.
- v. If the establishment remains open after 10:00 P.M. on any day, adequate safety and security arrangements shall be ensured for employees and visitors.
- vi. As establishments are being given permission to be open for all days new staff shall be appointed for the extended timing.
- vii. Female employees shall be provided separate locker, security and rest rooms at the work place.
- viii. Every employer employing women employees shall constitute Internal Complaint Committee against sexual harassment of women under the Sexual Harassment of Women at Workplace (Prevention Prohibition and Redressal) Act. 2013 (Central Act, 14 of 2013) and the said Committee shall be operative.
- ix. Female employee will not be allowed to work after 7:00 P.M. Their written consent in this regard shall be taken as adequate safety and security arrangements of female employees shall be made during working hours and it shall be ensured that they safely reach home after their work is over.
- x. The Prevention of The Child and Adolescent Labour (Prohibition and Regulation) Act 1986, as amended from time to time, shall be implemented in the establishments.
- xi. The employees shall be provided all the facilities mentioned in the relevant labour laws.
- xii. Consent letter shall be taken from the employees and it should be kept as record in the establishments.
- xiii. The spread over of an employee shall not exceed 11 hours in a day.
- xiv. Employee shall be given national and festival holidays with wages.
- xv. The wages including overtime wages of the employees shall be credited to their saving bank account.
- xvi. In addition to these terms and conditions, all the provisions of the Act and other relevant Laws shall be applicable to the establishment.
- xvii. In case of violation of any of the above terms and conditions or any other provision of the Act the exemption shall be cancelled after giving a due opportunity of being heard by the Competent Authority.

In continuation of the United Khasi-Jaintia District Fishery Act, 1954 and as empowered under the Rules 29 of the Assam and Meghalaya Autonomous District Council (Constitution of District Councils) Rules, 1951. Individual/party(s) shall from the date of this notification apply for and obtain permission from this Office for holding or organizing any fishing competition in any pond or river whether public or private within the Jurisdiction of Khasi Hills Autonomous District Council.
2. Application forms are available in the Head Quarter, Shillong and Branch Office of the Khasi Hills Autonomous District Council namely:-
  - (1) Ri-Bhoi Office – Nongpoh.
  - (2) South West Khasi Hills District – Mawkyrwat.
  - (3) West and Eastern West Khasi Hills District – Nongstoin.
3. Individuals/party applying for permission are required to fill up all details in the prescribed application form with supporting documents as stated in the application form and submit the same to the office.
4. Separate application must be submitted for fishing in private ponds, mentioning clearly the locality of the pond with the name and address of the owner accompanied by No Objection Certificate from the pond owner and the Village Headman of that locality.
5. Permission shall be issued only after due verification and inspection. The applicant who is issued with permission, shall be wholly responsible for maintenance of peace and tranquility in holding the fishing, competition. In the event of any cancellation or postponement of the competition it shall be the duty and responsibility of the applicant/party(s) to inform the Officer in-charge Fisheries and to all concerned authority.
6. Permission given will also be communicated to the Deputy Commissioner, Superintendent of Police of the District concerned and also from the village Headman where the fishing competition is held.
7. The Officer in-charge Fisheries shall exercise his duty to ensure strict adherence to the conditions mentioned in the permission. In case any violation occurs, action will be taken accordingly.
8. Scheduled of fees/rate shall be prescribed by the Executive Committee Khasi Hills Autonomous District Council from time to time. The fees once credited cannot be refund.

This order shall take immediate effect.
