No.DC/L/VII/6/2013-2022/27/786. – In pursuance of Paragraph 11 of the Sixth Schedule to the Constitution of India, the following Amendment Act of the Khasi Hills Autonomous District Council is hereby published for general information:-

THE KHASI HILLS AUTONOMOUS DISTRICT (NOMINATION AND ELECTION OF THE SYIEM, DEPUTY SYIEM AND ELECTORS OF NONGSTOIN SYIEMSHIP) (SECOND AMENDMENT) ACT, 2022.

(Passed by the Khasi Hills Autonomous District Council on the 8th July, 2022)

ACT

to further amend the Khasi Hills Autonomous District (Nomination and Election of the Syiem, Deputy Syiem and Electors of Nongstoin Syiemship) Act, 2003.

Whereas it has become expedient to further amend the Khasi Hills Autonomous District (Nomination and Election of the Syiem, Deputy Syiem and Electors of Nongstoin Syiemship) Act, 2003 as amended, herein-after referred to as the “Principal Act” in the manner herein appearing.

Now, therefore, the Khasi Hills Autonomous District Council is pleased to make the following amendment to the “Principal Act” namely:-

1. Short title, Extent and Commencement –

This Act may be called **THE KHASI HILLS AUTONOMOUS DISTRICT (NOMINATION AND ELECTION OF THE SYIEM, DEPUTY SYIEM AND ELECTORS OF NONGSTOIN SYIEMSHIP) (SECOND AMENDMENT) ACT, 2022.**

(1) It shall extend to the whole of Nongstoin Syiemship.

(2) It shall come into force at once.

2. All words and expressions shall have the same meaning as defined in the Principal Act.

3. Amendment of Appendix I and Appendix II of the Principal Act:-


- (i) In Serial No. 8 of Appendix I, a forward slash “/” followed by the word “Nongkhar” shall be added after the word “Khar-rit”;
- (ii) In Serial No. 6 of Appendix II, a forward slash “/” followed by the word “Nongkhar” shall be added after the word “Khar-rit”.

STATEMENT OF OBJECTS AND REASONS

It has been considered necessary to further amend the Khasi Hills Autonomous District (Nomination and Election of the Syiem, Deputy Syiem and Electors of Nongstoin Syiemship) Act, 2003 as amended since the clan “Khar-rit” and “Nongkhar” are one and the same.

Hence, these amendments.


