A. Powers of the Medical Board: The Medical Boards have the power to:

- (i) Allow or deny termination of pregnancy beyond twenty-four weeks of gestation period after due consideration and ensuring that the procedure would be safe for the woman at that gestation age and whether the foetal malformation has substantial risk of it being incompatible with life or if the child is born it may suffer from such physical or mental abnormalities to be seriously handicapped.
- (ii) Co-opt other specialists in the Board and ask for any additional investigations if required, for deciding on the termination of pregnancy.

**B. Functions of the Medical Board: Following are the functions of the Medical Boards:**

- (a) To examine the woman and her reports, who may approach for medical termination of pregnancy.
- (b) Provide the opinion of Medical Board in Form D with regard to the termination of pregnancy

or rejection of request for termination within three days of receiving the request for medical termination of pregnancy.

- (c) To ensure that the termination procedure, when advised by the Medical Board, is carried out with all safety precautions along with appropriate counselling within five days of the receipt of the request for medical termination of pregnancy.
