**PRELIMINARY NOTIFICATION**

*(Under Section -11(1) read along with Section-40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)*

**No.RDA.10/2020/54.** - Whereas it appears to the Government of Meghalaya that a total of 517B-4K-19L or 6,93,079 Sq. meters land is required in Rompara Village, North Garo Hills under Nokma A-king Land of Resubelpara for setting up of Police Reserve described in the statement attached.

Social Impact Assessment study was exempted by the Govt. *vide* letter No.RDA.10/2020/44, dated Shillong, the 29<sup>th</sup> September, 2023.

Therefore, it is notified that for the above said Project in Rompara village under North Garo Hills District, a land measuring 517B-4K-19L / 6,93,079 Sq. meters whose detail description is given in the statement to this Notification, is under acquisition.

This notification is made under the provisions of Section - 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30/2013) to all whom it may concern.

A plan of the land may be inspected in the office of the Collector on any working day during the working hours.

The Government is pleased to authorize District Collector and his staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil & do all other acts required for the proper execution of their work as provided and specified in section 12 of the said Act.

Under Section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase, etc., or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.
