**No.PRI.60/2021/190.** - The Inspector General of Prisons & Correctional Services, Meghalaya, Shillong invites Sealed Tenders affixing non-refundable Court Fee Stamp of ₹ 100/- for entering into rates contract for supply of Great Coats (Khaki Uniform) to the Personnel of all the District Prisons & Correctional Homes in Meghalaya for the year 2023-2024, 2024-2025 from the Manufacturers, Authorized Agents and Dealers. Sealed Tender accompanied with Sealed Samples of individual items quoted will be received upto 12:00 hrs. on 4<sup>th</sup> March, 2024 and will be opened on the same day at 3:00 p.m. Tenderers or their Authorized representatives may remain present at the time of opening of tenders. Tenders/Samples received after 12:00 hrs. by hand or post will stand automatically rejected. Sealed Tenders should be dropped in the Tender Box of this Office.

1. Tenderers should quote specific rates for each item. Tenders must be accompanied by Earnest money at a lump sum amount of ₹ 25,000/- (Rupees twenty five thousand) only. The Earnest money should preferably be in the form of Deposit at Call/Call deposit pledged in favour of the Inspector General of Prisons & Correctional Services Meghalaya, Shillong. Earnest money in any other recognized forms like the National Savings Certificate and Fixed Deposit Receipt are also acceptable provided they are duly pledged in favour of the Inspector General of Prisons & Correctional Services, Meghalaya, Shillong. Suppliers belonging to Scheduled Castes / Scheduled Tribes / OBCs are required to deposit half of the Earnest Money as indicated above. However, Suppliers / Firms belonging to ST / SC /OBC should furnish the attested copies of their respective caste certificates issued by the competent Authority. The Earnest Money / Security Deposit papers pending in this office in connection with other tenders / supplies shall not be considered as Earnest Money for this tender. Further, no tender is exempted from the requirement of depositing Earnest Money on any ground.
2. The tender will be in two Bids *i.e.* Technical Bid and Price Bid. Separate Bids should be submitted. The Samples should be packed together and clearly written as "SAMPLES FOR SUPPLY OF GREAT COATS (KHAKI UNIFORM) FOR THE PERSONNEL OF ALL THE DISTRICT PRISONS & CORRECTIONAL HOMES IN MEGHALAYA". A separate Price Bid should be submitted and the Envelope indicated as "PRICE BID FOR SUPPLY OF GREAT COATS (KHAKI UNIFORM) FOR THE PERSONNEL OF ALL THE DISTRICT PRISONS & CORRECTIONAL HOMES IN MEGHALAYA". The Price Bids will be opened only after the Samples have been selected by the Technical Committee. Only the Price bids of the Bidders whose samples have been accepted by the Technical Committee will be opened.
3. Rates should be quoted F.O.R. (Freight of rail) destination at all the District Prisons & Correctional Homes in Meghalaya and should be inclusive of all charges like packing insurance and other incidental charges. Rates quoted should be clearly and neatly written in figures as well as in words. All correction / cancellation must be initialed, otherwise tender will stand rejected. GST should be quoted separately on taxable items as deduction of Tax at Source will be effected on Firm's bills, accordingly.
4. Tenders should be addressed to the Undersigned by designation and not by name. The sealed envelope containing the tender should be superscribed as "TENDER FOR SUPPLY OF GREAT COATS (KHAKI UNIFORM) for Prisons & Correctional Homes personnel during 2023-2024, 2024-2025" and be posted under registered cover or sent through Messenger.
5. All the relevant Documents / Certificate pertaining to GST rules *Viz.* GST Registration Certificate / GST rate of the items quoted, should be submitted along with the following:
  - (i) Professional Tax Clearance Certificate.

- (ii) Attested copy of valid Trading License from the concerned District Council, Meghalaya in case of non-tribal firms / suppliers.
  - (iii) An Attested copy of Photograph of the Tenderer.
  - (iv) An Undertaking that the supply will be made by the Tenderer himself / herself and will be delivered to all the District Prisons & Correctional Homes according to the Supply order.
6. Tenderers should submit only 1 (one) sample for each item quoted.
  7. All Samples submitted must clearly bear the Manufacture's marking and Specification, Brand name, etc. along with the Firm's label attached on each sample.
  8. Tenderers who are Authorized Agents/Dealers of the Principal Manufacturers may submit the Authorized Dealership Certificate.
  9. The risk with respect to transportation will have to be borne by the Suppliers themselves.
  10. Tenderers should be prepared to accept item-wise rates approved by the Department otherwise their Earnest Money may be forfeited.
  11. The Inspector General of Prisons & Correctional Services, Meghalaya, Shillong is not bound to accept the lowest tendered rates.
  12. The Undersigned reserves the right to cancel the NIT floated or reject any tender without assigning any reasons therefor.
  13. Any dispute arising out of the Terms & Conditions of a Contract Agreement shall lie within the jurisdiction of the Courts of Meghalaya.
  14. At the time of opening of Tender, should there be any objection raised by the Tenderers / Representatives present as to the validity of any tender, the objection will be duly recorded and will be put up to the Departmental Purchase Board for consideration. The decision of the Departmental Purchase Board on such objection will be final and binding.
  15. The successful tenderers will be intimated by a letter of acceptance by the Inspector General of Prisons & Correctional Services, Meghalaya, Shillong. Till then, no Tenderer has any right to assume that his / her tender has been accepted.
  16. In the event of Supplier's failing to perform his / her part of the contract to the satisfaction of the Department or disregard any terms or conditions of the Tender or the Contract Agreement, the Supplier shall be liable to all or any of the following actions :-
    - i) Forfeiture of Security Deposit in whole/part.
    - ii) Making good the loss caused to the Government through the inability, neglect or delaying to comply with the demand.
    - iii) Imposition of penalty (fine) in case of failure to make the supply within the stipulated time at the rate of 0.50% on the total amount of supply ordered for everyday not exceeding 2 weeks, on the total supply or value of item(s) ordered for and for liquidated damages.
    - iv) Cancellation of the contract without any prior notice to the Supplier.
    - v) All losses sustained by the Government due to failure, omission or neglect of the Supplier may be realized from his / her Security Deposit and Outstanding dues or any other sums which may be due to him / her from the respective Controlling Officer.
  17. If the Supplier wilfully neglects, fails to perform or observe any conditions of contract, or attempts to cheat or indulges in malpractice, the Inspector General of Prisons & Correctional Services, Meghalaya may take necessary action to impose ban upon such Supplier from future business with this Department.

18. Successful Tenderers will be required to furnish a Security Deposit and execute Contract Agreement to ensure fulfilment of the Terms & Conditions of the Contract. The Security Deposit will be held by the Department free of interest and the deposit shall be subjected to forfeiture in case of non-fulfilment of any of the terms and conditions of the Contract.

The Earnest Money of successful Tenderer will be released only after he/she furnishes the full Security Deposit within the time fixed by the Department for the purpose, failing which, the Earnest Money may be forfeited to the Government. Earnest Money of unsuccessful Tenderers will be released by the Department after the selection process is finalized.

19. Tenders not accompanied by all the required papers / documents or not fulfilling the Terms & Conditions will automatically stand rejected.

20. Once the rates offered in the tenders are accepted, no enhancement of rates will be accepted under any circumstances and the Tenderer will be liable to supply at the rates approved and accepted by the Inspector General of Prisons & Correctional Services, Meghalaya. Failure to make the supplies at the approved and accepted rates will entail cancellation of Contract Agreement and the Security Money will be forfeited to the Government.

21. Once the Sample is approved, no change of brand name, shade pattern, quality or specification will be entertained even on the plea of non-availability of raw materials or alternative offers of similar quality.

22. The stores supplied must be of the same specification, weight, brand and quality as per tendered samples. Tenderers will have to furnish the counter samples within 2 (two) weeks of receipt of intimation regarding acceptance of tender. Failure to submit counter-samples in time, as per the specification of the approved sample will entail cancellation of offer and forfeiture of Earnest Money/Security Deposit.

23. (A) Delivery shall have to be completed within 8 (eight) weeks from the date of receipt of supply orders. No extension of delivery period will be entertained beyond the stipulated period unless the approved supplier submits irrefutable grounds for extension of delivery. In case of the plea that the approved items are no longer manufactured because of which the supply cannot be made, an authenticated certificate in original from the concerned manufacturer should be furnished. No computer generated documents/certificates will be accepted.

(B) The application for extension of time must be submitted to this office not later than the date fixed for completion of the supply. Applications for extension of time received after the date fixed for completion of the supply will not be considered.

24. Payment will be made to the supplier directly on completion of supply and on correct receipt of goods by the respective consignee. Documents/Vouchers/R.R. bills etc., routed through Banks will not be accepted. Consignments will be dispatched by the Supplier after payment of all freight charges at source. Freight to pay 'R.Rs' will not be accepted.

25. Tax at source will be deducted as per rates applicable, from the Supplier's bill, by the District Prison & Correctional Home / Headquarter office concerned.

26. Tenderers may note that all unapproved Samples submitted by them are returnable. The Samples should be collected by the Tenderers at their own cost and risk from this Office failing which, the Samples will be forfeited to Government. If the unapproved Samples are not collected by the unsuccessful Tenderers within 1 (one) month of finalization of the tender by the Departmental Purchase Board, the same will be disposed of by the Department without any compensation to the unsuccessful Tenderers.
