PRELIMINARY NOTIFICATION

(Under Section 11 (1) read with Section 40 of the Act-30/2013)

The 7th May, 2024.

No.RDA.31/2023/37. - Whereas it appears to the Government of Meghalaya that a total of **13,199.57 Sq.ft or 1226.28 Sq. Mts.** of land is required in the villages of **Umlyngkdait**, Ri-Bhoi District, for the Construction of Office – *cum* - Residential Complex (OCR) for the Subsidiary Intelligence Bureau (SIB) as per boundaries described in the schedule attached at Annexure - I.

This notification is made under the provision of Section 11(1) *read* along with Section 40 of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation & Resettlement Act, 2013 (Act No.30/2013) to all whom it may concern.

Additional Deputy Commissioner (Revenue), Ri Bhoi District, Nongpoh is appointed as Administrator for the purpose of Rehabilitation and Resettlement of the affected families.

Therefore, it is notified that for the above said project in the villages of Umlyngkdait, Ri Bhoi District, a piece of land measuring more or less **13,199.57 Sq.ft or 1226.28 Sq.Mts** whose details description is given in schedule to this notification, is under acquisition.

This notification is made under the provisions of section 11(1) *read* along with Section-40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No.30/2013), to whom it may concern.

A plan (Survey map) may be inspected in the office of the Deputy Commissioner, Ri Bhoi District on any working day. The appropriate Government is pleased to authorize the Deputy Commissioner and his staff to enter upon and survey land, take levels of any land dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provided and specified in section 12 of the said Act.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase, specified in the preliminary notification or create any encumbrance on such land from the date of publication of such notification without prior approval of the District Collector.

Objections to the acquisition, if any, may be filed by the person interested within 60 (sixty days) from the date of publication of this notification as provided under section 15 of the Act before District Collector.
