#### GOVERNMENT OF MEGHALAYA NOTIFICATIONS

**No.RDS.91/2014/386-** In exercise of the power conferred under Clause (a) of Section 11 of the Meghalaya Transfer of Land (Regulation) Act, 1971 (Act I of 1972) as amended, the Governor of Meghalaya is pleased to specify the Meghalaya Rural Bank as a Banking Company for the purpose of Clause (a) of Section 11 of the Act aforesaid.

**No.POWER.8/2018/Pt/15-** At present, all Government Departments are authorized to disburse payment of electricity bill from the Budget Provisions of the Respective Heads of Accounts. However, to streamline and expedite the process of clearing all current and outstanding electricity dues by MeECL in respect of Government buildings excluding Government Quarters the following new procedure shall be henceforth adopted.

- 1) All electricity dues/ bills will be paid by the Government in the Power Department from the available budget provision under Power Department.
- 2) All Departments are hereby instructed not to make any future payment on account of electricity bills from their respective Head of Accounts except for those offices occupied under rental accommodation from private individuals.
- 3) MeECL/MePDCL will raise the electricity bill on all Government Buildings in the usual manner but not to be paid by respective Government Department/Office.
- 4) Bills raised in the above manner, will be compiled in detail in the office of MeECL/MePDCL, indicating in detail the name of consumer, contact Number, Meter Number, Units consumed and amount of each unit in a statement in respect of all Government Department/Offices for onward submission to Power Department for making necessary payment.
- 5) The copies of the original bill raised at Sl.4 above should be maintained properly by MeECL/MePDCL, which will be subject to verification by Power Department from time to time.
- 6) Electricity bill in respect of rented accommodation will be paid by the respective Government office in the regular manner from the respective Head of Accounts. While submission of such claim/bills at the Treasury Office, they are to furnish a certificate that the bill is of a rented accommodation. Sufficient budget provision is to be kept in the respective Head of Accounts to make payment only for electricity bills rented accommodation.
- 7) Electricity bill on Government Quarters are not covered by this Notification, such bills are to be cleared by the respective Government employee.
