No.Health.111/2018/337- In exercise of the power conferred by the *proviso* to Article 309 of the Constitution, the Governor of Meghalaya is pleased to make the following Rules, to further amend the Meghalaya Medical Attendance Rules, 1981, as follows:

1. Short title, commencement:- (i) These rules may be called the Meghalaya Medical Attendance (Amendment) Rules, 2021.
(ii) They shall come into force at once.
2. Addition of new clauses to Sub-Rule (3) of Rule 10 of the Principal Rules (Meghalaya Medical Attendance Rules), after clause (azxxxxxiv), the new empanelled hospitals shall be added namely,
