### THE CONTINGENCY FUND OF MEGHALAYA (AMENDMENT) ORDINANCE, 2025

AN

### ORDINANCE

further to amend temporarily the Contingency Fund of Meghalaya Act, 1972.

Whereas, the Legislative Assembly of Meghalaya is not in session and the Governor is satisfied that circumstances exist which render it necessary for him to take immediate action;

Now, therefore, in exercise of the powers conferred by clause (1) of Article 213 of the Constitution, the Governor of Meghalaya is pleased to promulgate in the Seventy Sixth Year of the Republic of India the following Ordinance, namely,-

**Short title and Commencement.**


1. (1) This Ordinance may be called the Contingency Fund of Meghalaya (Amendment) Ordinance, 2025.
- (2) It shall come into force at once.

**Amendment of Section 2.**

2. In Section 2 of the Contingency Fund of Meghalaya Act, 1972 (No. 5 of 1972) for the existing proviso, the following new proviso, shall be added, namely;


"Provided that during the period beginning on the date of commencement of the Contingency Fund of Meghalaya (Amendment) Ordinance, 2025 and ending 31<sup>st</sup> March, 2025, this Section shall have effect subject to the modification that for the words "five hundred and five crore" the words "one thousand and five crore" shall be substituted."

### MEGHALAYA STATE INVESTMENT PROMOTION & FACILITATION (AMENDMENT) ORDINANCE, 2024

AN

### ORDINANCE


to amend the Meghalaya State Investment Promotion & Facilitation Act, 2024 (Act No. 6 of 2024).

Whereas, the Legislative Assembly of Meghalaya is not in session and the Governor is satisfied that circumstances exist which render it necessary for him to take immediate action;

Now, therefore, in exercise of the powers conferred by clause (1) of Article 213 of the Constitution, the Governor of Meghalaya is pleased to promulgate in the Seventy-Sixth Year of the Republic of India, the following Ordinance, namely,-


- Short title and Commencement.** 1. (1) This Act may be called the Meghalaya State Investment Promotion & Facilitation (Amendment) Ordinance, 2024.
- (2) It shall come into force on the date of its publication in the official Gazette.
- Amendment of Section 4.** 2. (1) The existing sub-section (1) to sub-section (8) of Section 4 shall be renumbered as sub-section (2) to sub-section (9) and a new sub-section (1) shall be added, as follows,-
- "(1) The Nodal Agency will be responsible for promoting the investment ecosystem in the State and taking up all activities relating to setting up Industrial or service sector undertakings and the promotion of economic development in the State. This includes conducting investment facilitation, events, roadshow across the country and internationally, creation of land-banks through direct purchase of land or other means, and setting up of the offices."
- (2) In existing Section 4 after sub-section (9) a new sub-section (10) shall be added, as follows,-
- "(10) The Invest Meghalaya Authority shall submit proposals for Customized Package of incentives for investments exceeding Rs. 100 crores to the State Cabinet for approval."
- Amendment of Section 9.** 3. The existing clause (h) of sub-section (2) of Section 9 of the principal Act shall be omitted.
