No.PER.5/88/Pt.I/259. - The following Notification issued by the Govt. of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training, New Delhi is republished for general information.

"Notification No.11031/06/2019-AIS-II, dated 3rd February, 2025"

G.S.R.78 (E) - In exercise of the powers conferred by sub-section (1) of Section 3 of the All India Services Act, 1951 (61 of 1951), read with sub-rules (1) and (2) of rule 4 of the Indian Administrative Service (Cadre) Rules, 1954, the Central Government, in consultation with the Govt. of **Assam - Meghalaya** hereby makes the following regulations further to amend the Indian Administrative Service (Fixation of Cadre Strength) Regulations, 1955 namely:

- (1) These regulations may be called the Indian Administrative Service (Fixation of Cadre Strength) Second Amendment Regulations, 2025.
(2) They shall come into force on the date of their publication in the Official Gazette.
- In the Indian Administrative Service (Fixation of Cadre Strength) Regulations, 1955 in the Schedule, for the heading "Assam-Meghalaya" and the entries relating thereto, the following shall be substituted namely:-

G.S.R.79(E) - In exercise of the powers conferred by sub-section (1) of Section 3 of the All India Services Act, 1951 (61 of 1951), the Central Government in consultation with the Government of Assam-Meghalaya hereby makes the following rules further to amend the Indian Administrative Service (Pay) Rules, 2016 namely:-

1. (1) These rules may be called the Indian Administrative Service (Pay) Second Amendment rules, 2025.
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Indian Administrative Service (Pay) Rules, 2016 in the Schedule II:-
