No.RDA.19/2007/154. - Whereas it appears to the Government that a total of 1,19,008.2 Square Metres (8B-4L-10L) of land is required in Diplipara Village, South Garo Hills, District for public purpose, viz, for construction of Border Out Post for the Border Security Force (B.S.F.).

Therefore, declaration is made that the plot of land measuring more or less 1,19,008.2 Square Metres (8B-4L-10L) of standard measurement in Diplipara Village, South Garo Hills District as per detailed description below, is under acquisition for the above said project and is required to be taken by the Government for public purposes:-

The Declaration is made under Section 19(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30/2013) after Public Notice is given on 24th October, 2024 for claims and objections from interested persons as provided under Section 21 of the said Act. The number of families likely to be resettled due to land acquisition is Nil.
