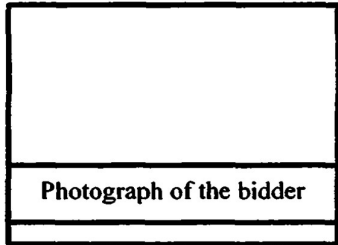

**8. Award of contract and payment terms and conditions:**

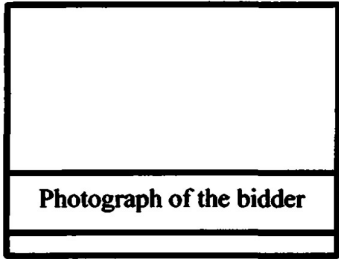

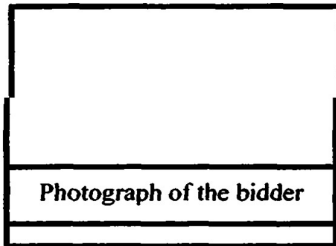
