No.NSTDA/Tech/7/2025/1. - Shillong, the capital city of Meghalaya, is a prominent centre for education in the North-Eastern region. However, the city is currently facing infrastructural limitations that restrict its capacity for further development. To address these challenges, the Government of Meghalaya has initiated the development of New Shillong City in a phased manner, comprising of Administrative City and the Knowledge City. The presence of premier institutions such as the Indian Institute of Management (IIM), National Institute of Fashion Technology (NIFT), Institute of Hotel Management (IHM), and National Law University (NLU) in New Shillong City has created a strong academic foundation, positioning the area for further institutional expansion.

Building on this foundation, 807 acres have been earmarked for the development of the Knowledge City in Mawpdang-Mawkhanu. Knowledge City is being developed with the objective of establishing a nationally recognised hub for academic excellence, research, and innovation. A detailed master plan is currently under preparation to guide the development.

In pursuit of this vision, the Government of Meghalaya, through the New Shillong Township Development Agency (NSTDA), **Invites Expressions of Interest (EOI)** from reputed **National and International Educational Institutions** to set up Campuses and Skilling Hubs in the Knowledge City.

The Government of Meghalaya will support selected proposals through land allocation and Viability Gap Funding (VGF) under a challenge-based model. All proposals will be evaluated based on merit, institutional capacity, and alignment with the objectives of the Knowledge City.

The evaluation of proposals will be undertaken by a Selection Committee chaired by the Commissioner & Secretary, Urban Affairs Department, with members including the Director, School Education and Literacy; Executive Director, Meghalaya State Skill Development Society; Director, Urban Affairs; and Superintending Engineer, NSTDA.
