**PRELIMINARY NOTIFICATION**

*(Under Section 11 (1) Read with Section 40 of the Act – 30/2013)*

The 14<sup>th</sup> October, 2025.

**No.RDA.02/2025/91.** - Whereas it appears to the Government of Meghalaya that a total of **579911.8 Square Meters** land is required in Bandapara, Cherengpara, Makaburipara, Jatrakona, Silbaripara, Gandibor, Gasuapara, Gobrakura, Sibbari, Banajuri, Domdoma, Rongdotchi, Rasnagre, Nilwagre, Nilwa A-dinggre, Dasangre, Bidoiboi, Netri, Dabram, Arapara, Jongkol, Makbilkol and Wagesik Villages of South Garo Hills District, for construction of Indo-Bangladesh Border fencing as per boundaries described in the statement attached.

Therefore, it is notified that for the above said IBBF in Bandapara, Cherengpara, Makaburipara, Jatrakona, Silbaripara, Gandibor, Gasuapara, Gobrakura, Sibbari, Banajuri, Domdoma, Rongdotchi, Rasnagre, Nilwagre, Nilwa A-dinggre, Dasangre, Bidoiboi, Netri, Dabram, Arapara, Jongkol, Makbilkol and Wagesik Villages of South Garo Hills District, a piece of land measuring more or less **579911.8 Square Meters** whose detail description is given in the statement attached to this notification, is under acquisition.

This Notification is made under the provisions of Section 11(1) of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30/2013), to all whom it may concern.

A plan of the land may be inspected in the office of District Collector, South Garo Hills District on any working day during the working hours.

The appropriate Government is pleased to authorize the District Collector and his staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provided and specified in Section 12 of the said Act.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land that is sale/purchase, specified in the Preliminary Notification or create any encumbrances on such land from the date of publication of such notification without prior approval of the District Collector.

This notification is made under the provision of Section 11 (1) of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.
