**No.ERTS(T)3/2025/445.-** In exercise of the powers conferred by sub-section (1) of section 11 of the Meghalaya Goods and Services Tax Act, 2017 (10 of 2017), the Government, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government Excise, Registration, Taxation and Stamps Department, No. 26/2018 - State Tax (Rate), dated 31<sup>st</sup> December, 2018, published in the Gazette of Meghalaya, Extraordinary, Part-IIA, *vide* number 14, dated the 18<sup>th</sup> January, 2019, namely:-

In the said notification, in the Explanation, for clause (c), the following clause shall be substituted, namely,-

"(c) "Nominated Agency" means entities mentioned in Lists 13, 14 and 15 appended to Table 1 of notification No.45/2025 - Customs, dated the 24<sup>th</sup> October, 2025 published in the Gazette of India, Extraordinary, Part II, Section 3 Subsection (i);"

2. This notification shall come into force with effect from 1<sup>st</sup> day of November, 2025.
